

**TRIPTYCH**  
**AMENDMENT TO THE ARTICLES OF ASSOCIATION OF TRIODOS BANK N.V.**

Triodos Bank N.V. (**Triodos Bank**) proposed to amend its articles of association in accordance with the draft articles of association included in this triptych. The proposed changes are accompanied with an explanatory note for the extraordinary general meeting of Triodos Bank, which shall be held in Zeist on 23 October 2024 (the **EGM**).

The proposed amendments relate to the listing of depository receipts of shares in the capital of Triodos Bank and the admission to trading on the regulated market of Euronext Amsterdam. The first column contains the text of the existing articles of association. The second column contains the text of the proposed amendments, included in blue (text additions) and in ~~red~~ (text deletions). The third column includes an explanatory note to these changes.

The proposed amendments contained in the second column include the amendments intended with agenda item 4.a. as well as agenda item 4.b. of the EGM. The relevant deeds of amendment can be found on [triodos.nl/ava](https://triodos.nl/ava).

It should be noted that this is a translation into English of the original Dutch version of the articles of association. An attempt has been made to be as literal as possible without jeopardizing the overall continuity. Inevitably, differences may occur in translation, and if so, the Dutch text will by law govern.
